Privacy

5TM respects your right to privacy and does not collect any personal information on these websites about you without your request, or explicit consent.

Responsible for Treatment

Personal Data Security

5TM, in the pursuit of its activities, uses a set of technologies and procedures adapted security measures to protect your data, protecting access and unauthorized disclosure namely:

- Physical security measures, namely the control of employee access, employees and visitors to the headquarters premises and, on the premises of data centers and computing, very limited intrusion-fighting mechanisms, fire extinguishing, monitoring of equipment 24x7, and with the possibility of hosting equipment in dedicated servers;
- Logical security measures, in the component of access to systems and service stations work through mechanisms of identity management, authentication, and privileges; at network component the use of firewalls and intrusion detection systems.

Access and control of Personal Data
